

## PRIVACY STATEMENT

The European Pulmonary Hypertension Association (PHA Europe) is committed to protecting your personal data irrespective of whether you provide us with them online or in a written form. From this privacy statement (Privacy Statement) you can learn how your personal data are handled, managed and processed by PHA Europe as well as what type of rights you have as data subject under the terms of the European General Data Protection Regulation (GDPR).

The Privacy Statement covers all pages, which are or will be hosted, maintained by PHA Europe, unless special privacy statement applies to a given webpage, which will be clearly shown and shall supplement this Privacy Statement.

PHA Europe uses the information it collects about you to

- better understand how its communication strategy, websites, Youtube, Facebook and other social media channel are used,
- send information and updates, you have requested or that may be considered of interest to you, on pulmonary hypertension and other rare diseases,
- provide updates, training opportunities and other news about PHA Europe, its affiliates, other partners, scientific communities, pharmaceutical partners, EU institutions and other associations PHA Europe is member of or has connection to,
- process your membership application and to render services you have ordered or which are included in your membership, or to assess the work done by PHA Europe.

To understand how your personal information will be treated, please read the following Privacy Statement. This Privacy Statement may change from time to time so please refer to it periodically. In addition, we will where applicable send you a notice of any such change.

## WHAT IDENTIFIABLE INFORMATION IS PROCESSED ABOUT YOU?

The type and amount of information processed by PHA Europe depends on how you use the resources and services PHA Europe is providing. You can access most PHA Europe pages without stating who you are and without revealing any personal information, however to have access to internal mailing list data considered personal information may be collected from you.

PHA Europe does not collect information identifying you personally (such as your name, address, phone number or e-mail address) unless that information is voluntarily disclosed. Kindly note however that you might be requested to provide personal information to comply with applicable laws or in order to receive any of the services PHA Europe is rendering. Once you do not provide information upon request, PHA Europe might refuse to provide the given service or provide it only with some limitation.

There are other instances where PHA Europe requests information that does identify you personally for the purpose of providing you with specific services or of corresponding with you. Information that you supply in this way will not be shared with any third party except where needed to provide a requested service or required by law.

If you register for a newsletter, log on to certain PHA Europe websites, order a publication, request information, provide feedback, attend an online course, join a discussion group or join an electronic mailing list or newsletter, or request the assistance of PHA Europe to attend a face to face meeting, general assembly or any other meeting where the arrangement of your travel is needed, you may be asked to provide personal information such as your

- name
- nationality
- place and date of birth
- mother's name
- identification number or photocopy of your ID card
- bank account number
- postal address
- e-mail address.

This information is collected only with your knowledge and permission and is kept in various PHA Europe databases and mailing lists. If you are purchasing something or donating using a PHA Europe website, you may be asked to provide your credit card details. These details are transferred to a secure, third party online payment service provider, and PHA Europe will nor have access, neither will retain, manage, store, host or process such information.

## HOW YOUR INFORMATION IS USED BY PHA EUROPE?

PHA Europe does not distribute, sell, make available or grant access to the user information to third parties, unless it is required by applicable law, or needed to improve PHA EUROPE's understanding of web visitors, to send information that you have requested or that may be considered of interest to you and to render services you have asked for.

## WITH WHOM MAY PHA EUROPE SHARE THE INFORMATION?

PHA Europe will not disclose any information identifying you personally, except with your prior explicit permission, to service providers to render the service you requested or where required by applicable law.

## RIGHTS YOU HAVE RELATED TO THE DATA PROCESSING OF PHA EUROPE

## WHAT CHOICES ARE AVAILABLE TO YOU REGARDING COLLECTION, USE AND DISTRIBUTION OF THE INFORMATION?

Any information on new PHA Europe activities that you registered to receive will be sent to you electronically or by other means. PHA Europe may also send you e-mail messages and newsletters which you consented to and are of interest to you. You can indicate that you do not wish to receive such e-mail messages or newsletters by using the unsubscribe link in the newsletters or emailing us at [info@phaeurope.org](mailto:info@phaeurope.org) and you will be removed from the recipients' list.

## HOW DOES PHA EUROPE PROTECT YOUR PERSONAL INFORMATION?

PHA Europe endeavors to ensure high level of protection of your personal information you provide with us. However, it cannot guarantee that submitting information over the Internet is completely secure and data are not compromised. As a result, PHA Europe does not confirm or warrant the security of personal information submitted ; you do so at your own risk. Please also note that PHA Europe may store your information in private clouds and the (secure) copy thereof might be outside the European Union.

## COOKIE POLICY

PHA Europe websites use cookies in order to provide you with a more personalized web experience. A cookie is a text-only string of information that is created and stored on your computer by your browser. It contains information about your visit that your browser uses to personalize certain pages or elements. For statistical analysis purposes, a cookie may also be used to pass a randomly generated and anonymous unique number to our servers. Cookies cannot be used by themselves to identify you. A cookie will typically contain the name of the domain from which the cookie has come, as well as the lifetime and expiration of the cookie, and a value, usually a text value or a randomly generated unique number.

If you do not wish to receive cookies, you can easily modify your browser to reject all cookies or to notify you whenever one is about to be placed on your computer.
